## How Streamwise D.I.™ helps water utilities

- 1. Easy installation: An out of the box, ready to go solution, Streamwise D.I.™ is sent directly to site for installation by either onsite personnel or one of our approved integrators.
- 2. Full visibility of your network: Using Streamwise D.I.™ data from a wastewater contributor is continually digitized and analyzed in a secure, advanced cloud based portal. This gives the water utility plant operators accurate, real-time data, insights and 24/7 visibility of the wastewater quality entering their network, with immediate alerts for compliance breaches. By deploying wireless video and imaging of a wastewater stream, information by time, flow or compliance excursions is also available.
- 3. Customized alarms: Alarm systems for each site are customized and automated, based on the trade waste agreement. Multiple alarms, via SMS and email, can be escalated to different management levels onsite and within the water authority for identification and rectification.
- 4. Automated billing & data integration: With Streamwise D.I.™ data can be linked (via APIs) to other operating systems such as the water authority's automated billing, as well as compliance and breach metrics.
- 5. Compliance monitoring: The Streamwise D.I.™ portal reports on compliance metrics such as total flow, instantaneous flow, pH, temperature, conductivity, turbidity or Total Suspended Solids (TSS).
